The services provided through Simple Wellness LLC (hereafter referred to as SW) or Mark Randall, DMM, N.D., D.PSc are intended to help you discover things you can do to improve your overall well being, optimize your level of wellness, prevent unnecessary emotional discomfort, and maximize your energy and productivity. We are delighted that you have chosen us to help you and look forward to working with you in positive ways.

As a new patient you should be fully informed about our policies and practices. Therefore we ask that you read the statements below and check the box before each one to indicate your understanding.

The services you will receive are religious in nature and, as a result, not subject to licensure or regulation by the State of Texas. SW/Mark offers alternative forms of help with a spiritual foundation that include Frequency Specific Microcurrent (FSM), PEMF (Pulsed Magnetic Field), Jade color/gem/sound microcurrent, LightStim (Red, Infrared & other light frequencies), blessed waters, and additional non-medical recovery methods such as prayer, meditation, moral guidance, holistic (Phys/Ment/Spirit) counsel/coaching, and education in natural self-help methods such as Healing Codes or EFT (Emotional Freedom Technique).

Privacy and Security of Your Personal Data: Any information and data we obtain from you or about you will be protected as secure, private, and confidential. Only members of the immediate staff who are involved in your care will have access to this information. We will not share this information with anyone else without your expressed written permission.

Informed Consent: Our overall approach involves careful psychological, spiritual and scientific evaluations supported by a variety of modalities. Consequently, much of what we do is considered “alternative” by the conventional counseling establishment. We work at dealing with the underlying causes of your problems. In some cases your regular doctors may not be familiar with or supportive of our approach. At all times, we will do our best to explain things to your complete satisfaction. It always will be your choice whether or not to proceed with our recommendations. When appropriate we will provide you with “informed consent” forms to review and sign for specific treatment protocols.

Your Primary Care Provider: The services provided through SW/Mark are not intended to replace your relationship with your regular health care provider or to serve as your source of routine health care. We strongly encourage you to establish and maintain an ongoing relationship with a primary care physician of your choice. We will be happy to communicate and coordinate our activities with this person should you desire it.

Emergency and After-Hours Services: Because the nature of our approach is preventive medicine we do not provide hospitalization services, acute care, or emergency response. We do not maintain “on-call” or “after-hours” services and recommend that you get assistance for any medical emergencies through your primary care physician. _____

Use of Controlled Substances: It is our policy to neither stock, nor prescribe, nor advise regarding controlled medications and narcotic drugs. _____

Emergency and After-Hours Services: In certain situations, a patient might need additional debriefing due to emotional triggers or possible relapse. Normally we do not provide “emergency or after hours services.” However, we do understand the need to talk through a difficulty. We will accept a phone call at such time if we are available to do so. If the phone is not answered immediately, please leave your name, phone number, and reason for the call. We will return the call as soon possible.

I will notify SW/Mark at least 24 hours prior if my appointment has to be changed. Failure to do so will result in a billing of \$75 plus any related expenses.

Payment Policy: Simple Wellness LLC / Mark Randall operates as a “fee for service” provider. This means that we do not accept insurance or third party payment (including Medicare and Medicaid). Instead, we request that you pay us at the time of scheduling or at time of service. We currently accept Cash, Check, and also PayPal (<https://paypal.me/DoctorRandall>) for credit cards, check cards, & bank accounts. Returned checks will be assessed a fee of \$38 and must be replaced by cash or money order. There is a \$50 round-trip charge for home visits.

Fee Structure: (Subject to change without notice)

- LightStim or microcurrent (FSM/Jade) Consultation - Free. (10-15 mins)
- Individualized “Holistic Optimization” Wellness Consultation - \$250. (1-1.25 Hr)
- Frequency Specific Microcurrent (FSM) & PEMF - \$51-450. (30min-2.5 Hr)
\$4 per minute wet towels &/or conductive graphite gloves, \$3 per min dry PEMF magnets (Pulsed Magnetic Field). Each FSM program varies in length.
- Light Facial - Reg. \$100. / \$50. Intro 1st Visit / \$50. “Add-on” same day service (All facials include product applied unless one elects not to use PhotoMasque and/or PhotoSerum with the LightStim Facial)
- Jade Facial - \$60. (always includes/uses Aculift white cream, hypo-allergenic)
